About the application for Minor Variance (Location sketch on back):

A5/2017WL – Helen Kzsan – Adrian Kuivenhoven (Agent)

The subject lands are east of Heaslip Road on the north side of Vaughan Road, being legally described as Concession 3 Lot 16 and 17, RP 30R8745 Part 1 in the former Township of Gainsborough now in the Township of West Lincoln, fronting Vaughan Road.

The subject lands are zoned as Rural Residential 'RuR' according to the Township Zoning By-law 79-14 as amended. Application has been made to request a minor variance from Section 7.33 of the Township Zoning By-law, to permit a reduced MDS I setback of 375 metres where a setback of 474 metres is required to permit the construction of a new dwelling. The existing lot was created in 1996 through application B159/96 as a retirement lot.

How to provide comment:

Any person may attend the meeting and/or provide written or verbal representation on the above noted Minor Variance. We ask that any written comments be provided by **Wednesday, March 15, 2017** to the Secretary-Treasurer of the Committee of Adjustment, Taylor Wellings, so that they may be incorporated into the staff report. Written comments may also be submitted at any time prior to the meeting date on **Wednesday, March 22, 2017**. Please be sure to include the file number and name for which file your comments are to apply.

Any written comments received with regard to this application will constitute part of the public record for this particular file, in accordance with the Planning Act.

Important information about making a submission:

If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect of the proposed consent does not make written submissions to the Committee of Adjustment before it gives or refuses to give a provisional consent, the Ontario Municipal Board may dismiss the appeal.

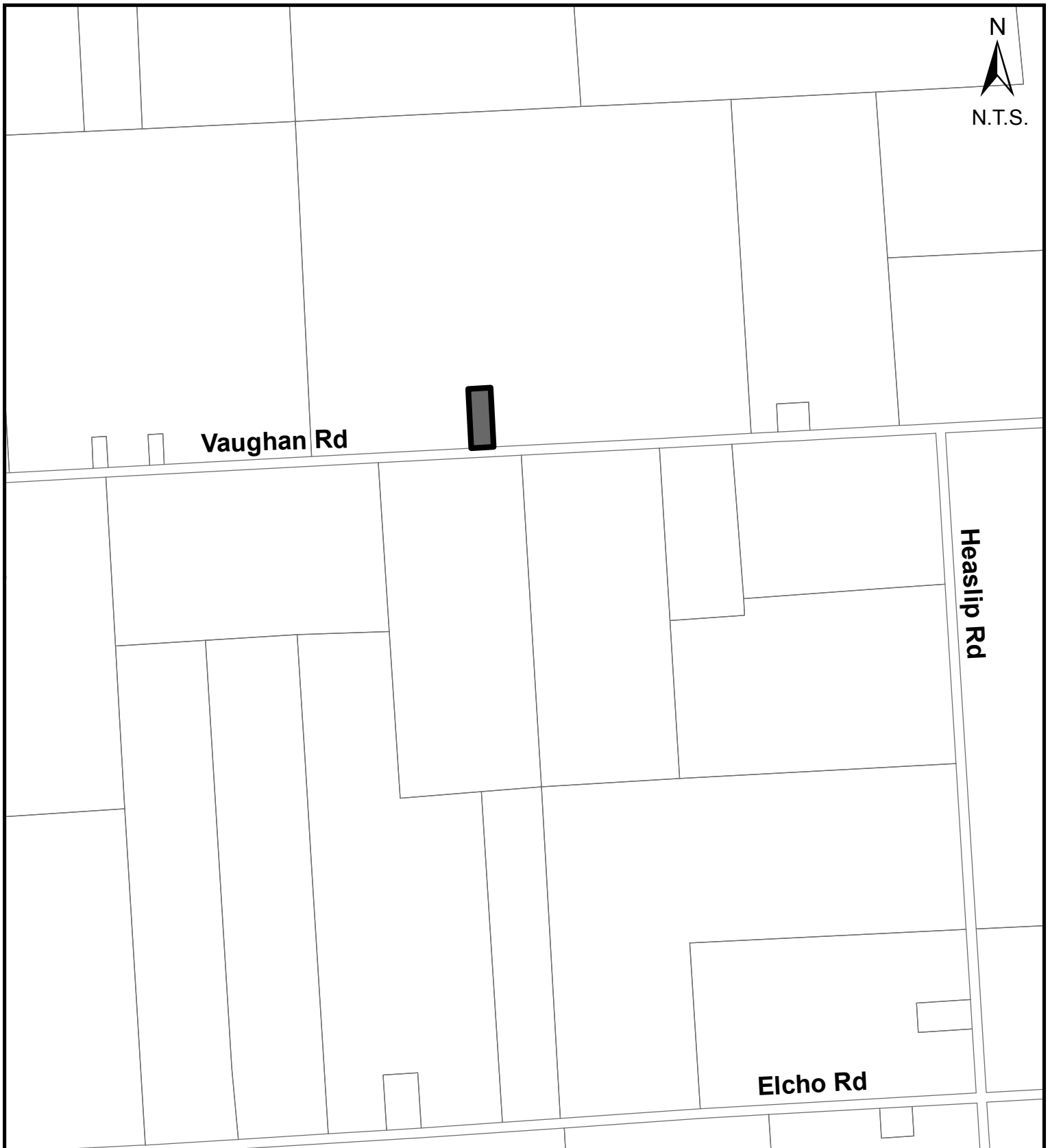
