Get involved with your input. The Township of West Lincoln Committee of Adjustment will hold a public hearing in accordance with Section 45 of the Planning Act at an accessible facility where the matter below will be considered. The meeting will take place:

About the application for Minor Variance (Location sketch on back):

A7/2015WL – Estate of Margaret Spittal

The subject lands are shown on the location sketch provided on the back of this notice and are legally described as Part Lots 11 & 12, Concession 5 in the former Township of Caistor, now in the Township of West Lincoln, and known municipally 1988 Caistor Centre Road (Part 1) and 8734 Concession 5 Road (Part 2). The subject lands are located on the south west corner of Caistor Centre Road, and Concession 5 Road.

The subject properties are currently zoned Agricultural A2 according to the Township's Zoning By-law 79-14, as amended. For the property located at **1988 Caistor Centre Road** relief is being requested to recognize a deficient side yard setback of 2.3 metres to an existing garage, whereas the Township's Zoning By-law requires 15 metres, and to request a reduction to the Minimum Distance Separation setback of 130 metres to the existing house from an adjacent livestock facility, whereas 213 metres is required. For the property located at **8734 Concession 5 Road** relief is being requested to recognize a deficient front yard setback of 14.5 metres whereas the Township's Zoning By-law requires 15 metres.

This minor variance application is required as a condition of consent (B3/2015WL).

We ask that any written comments be provided by **Wednesday, June 10th, 2015** to the Secretary-Treasurer of the Committee of Adjustment, Lauren Vraets, so that they may be incorporated into the staff report. 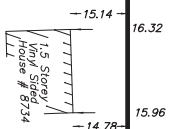

Also known as CONCESSION 5 ROAD

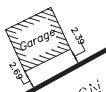
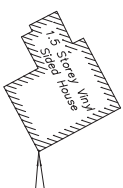


PARCEL 2

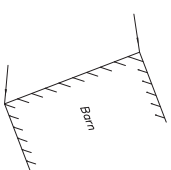
