THE CORPORATION OF THE TOWNSHIP OF WEST LINCOLN

BY-LAW NO. 2014-58

BEING A BY-LAW TO AMEND BY-LAW 2010-20 WHICH REGULATES AND LICENSES REFRESHMENT VEHICLES, REFRESHMENT CYCLES AND REFRESHMENT CARTS IN THE TOWNSHIP OF WEST LINCOLN.

WHEREAS the Council enacted By-law 2010-20 which regulates and licenses refreshment vehicles, refreshment cycles and refreshment carts in the Township of West Lincoln;

AND WHEREAS the Council deems it expedient to amend By-law 2010-20 which regulates and licenses refreshment vehicles, refreshment cycles and refreshment carts in the Township of West Lincoln, to provide for daily license fees, an exemption for not-for-profit organizations and the requirement for insurance;

NOW THEREFORE THE COUNCIL OF THE TOWNSHIP OF WEST LINCOLN ENACTS AS FOLLOWS:

- 1. That, By-law 2010-20 be amended by:
 - (a) Deleting Section 2(b) and replacing it with the following new Section 2(b):
 - 2(b) Every person who operates a refreshment vehicle, refreshment cart or refreshment cycle in the Township of West Lincoln shall pay a license fee as follows and a separate license shall be required for each refreshment vehicle, refreshment cart or refreshment cycle if more than one such refreshment vehicle, refreshment cart or refreshment cycle is operated by any one owner:

ANNUAL FEE:

Refreshment Vehicle \$400.00 per vehicle
Refreshment Cart \$400.00 per cart
Refreshment Cycle \$200.00 for first cycle;

\$50.00 for any additional cycles

DAILY FEE:

Refreshment Vehicle \$100.00 per vehicle Refreshment Cart \$100.00 per cart Refreshment Cycle \$50.00 for first cycle;

\$12.50 for any additional cycles

- (b) Deleting Section 2(c)1 and replacing it with the following new Section 2(c)1:
 - 2(c)1 No such licence is required:
 - 1. by a non-profit and/or charitable organization or persons who enters into a written agreement with a non-profit and/or charitable organization for attendance at a special event, show, festival, fair or fundraising event organized by the non-profit and/or charitable organization and only during the hours of operation of the organization's fundraising event or show, festival or fair, provided such person(s) shall have obtained all relevant inspections, liability insurance and approvals including fire, building and health and obtain the required.
- 2. That the binder of fees and charges as confirmed by By-law 2002-115, be updated to include the amended fees provided herein.
