

THE CORPORATION OF THE TOWNSHIP OF WEST LINCOLN

BY-LAW NO. 2017-19

BEING A BY-LAW TO AMEND BY-LAW 2004-42, AS AMENDED, WHICH REGULATES THE SUPPLY OF WATER AND PROVIDES FOR THE IMPOSITION AND COLLECTION OF WATER AND WASTEWATER RATES.

WHEREAS the Council of the Corporation of the Township of West Lincoln enacted By-law 2004-42, as amended, to regulate the supply of water and to provide for the imposition and collection of water and wastewater rates;

AND WHEREAS the Council of the Corporation of the Township of West Lincoln deems it expedient to amend By-law 2004-42 to impose new water meter rates, new wastewater rates and new water filling station rates which shall be effective July 1, 2017.

NOW THEREFORE THE CORPORATION OF THE TOWNSHIP OF WEST LINCOLN ENACTS AS FOLLOWS:

1. That Schedule "A" of By-law 2004-42 be deleted and the new attached Schedule "A – Water & Wastewater Rates" be inserted in lieu thereof; and,
2. That Schedule "C" of By-law 2004-42 be deleted and the new attached Schedule "C – Water Filling Station Rates" be inserted in lieu thereof; and,

READ A FIRST, SECOND AND THIRD TIME AND FINALLY PASSED THIS 27th DAY OF FEBRUARY, 2017.

WATER FILLING STATION RATES

1. WATER CHARGES

A consumptive rate of \$1.64 per cubic meter.

2. ACCOUNT DEPOSIT

- \$250.00 for each account provided to commercial area haulers.
- \$ 50.00 per day for infrequent private buyers.
