#### About the application for Minor Variance (Location sketch on back):

**A13/2018WL – Hendricus Johannes VanRyn**

**Property Address: 3525 Grassie Road**

A minor variance application has been submitted for 3525 Grassie Road to recognize an existing legal non-conforming use. Historically the property has been used as the principal location for a small trucking company and to store construction material such as gravel and dirt. The applicant is proposing to recognize the legal non-conforming use and storage use of these lands such that a change to like uses of storage and commercial activity are permitted.

**Any written comments received with regard to this application will constitute part of the public record for this particular file, in accordance with the Planning Act.**

**If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect of the proposed minor variance does not make written submissions to the Committee of Adjustment before it gives or refuses the minor variance application, the Local Planning Appeal Tribunal may dismiss the appeal.**

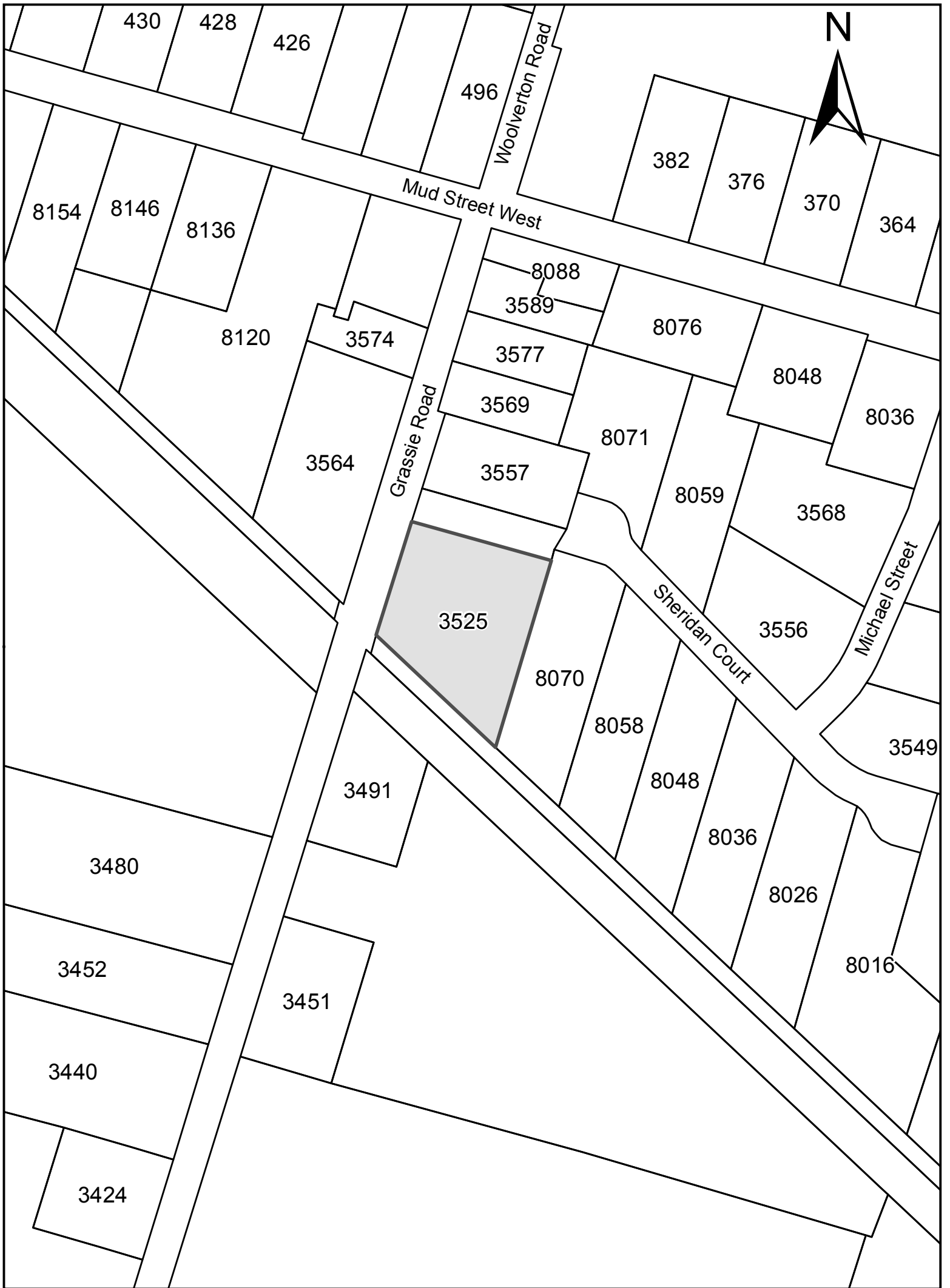
